### Facility, Check-In, Crating, and Food

Doors Open at **7:00A.M.** on September 29. Please do not arrive prior to this time. General briefing, Judge’s briefing, and walkthroughs will begin at 7:45am, with the first dog on the start line at **8:00A.M.** Trial 2 will follow Trial 1. Trial 3 will follow Trial 2, but will not start before **12 Noon**. Plenty of indoor crating space is available.

Vendor onsite with homemade dog treats.

Entries limited to 200 for the day. Move-ups will be allowed between trials both in Level and in Class. Move ups from A to B classes are mandatory and will be made day-of-trial by the Secretary.

Dogs will be crated in a separate room from the ring location. Members and trial committee may crate in same room as show ring. Water is available in restrooms and a sink in show area.

The ring dimensions are 40 x 60 ft. and the ring is enclosed with folding ring gates.

A continental breakfast and a full lunch and beverages will be available for purchase on site.

### Awards

Both “A” and “B” classes will receive placement ribbons and flat qualifying ribbons. Title, Level Champion and Combined Championship rosettes will also be provided.

**Directions to the Show Site** Take I-70 West to Indianapolis. Take St. Rt. 49 North to Greenville. Follow St. Rt. 49 to the St. Rt. 127 bypass going around Greenville. Follow St. Rt. 127 to the exit for Greenville and Piqua, St. Rt. 36. Turn west onto Martin St, or ST. RT.36. This will take you to the first stop light at the corner of Ohio and Martin St. Turn left or South at this intersection on to Ohio St. and go 3 streets. The third street is Front St. and only turns right. Proceed two blocks and take a jog to the right and immediately take a jog left. This is still Front St. and the building is to the right. Address 940 is on the front of the building. There is parking around the building and in the rear parking lot off of Hart St. that runs by the west side of building. No entry to the show building from the front or west door day of trial, only from two rear doors coming from parking lot. Crating is in the rear building. Food will also be served in that building.

### Rally Class Description

You must be familiar with all the Rally exercise signs, as well as the Rally Rules and Guidelines prior to the event. Go to [www.rallydogs.com](http://www.rallydogs.com) for an explanation of each of the exercise signs and have fun practicing them with your dog.

### A and B Classes

"A" classes are for teams that have NOT yet completed their title at that level.

"B" classes are for teams that have already completed their title at that level.

### Jump Heights

The following table shows the recommended and minimum allowable jump heights based upon the dog's height at the withers:

Height at Withers	Minimum Allowable Jump Height	Recommended Jump Height
12" or less (30cm)	4" (10cm)	4" (10cm)
16" or less (40cm)	4" (10cm)	8" (20cm)
20" or less (50cm)	8" (20cm)	12" (30cm)
Over 20" (50cm)	12" (30cm)	16" (40cm)

The minimum allowable jump height for each height category is the minimum height permitted without a Request for Modification being made.

### Veteran Class

Open to all dogs who meet the age and weight eligibility as set forth in the following table:

Dog's Weight	Dog's Minimum Age for Veteran Class
90 pounds (41kg) or more	6 years
50 pounds (23kg) or less	7 years
under 50 pounds (23kg)	8 years

Competitors, through submission of entry, acknowledge that they are knowledgeable of WCRL rules and regulations (see [www.rallydogs.com](http://www.rallydogs.com)), including but not limited to the following rules regarding entry:

- This trial is open to a dog at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries, or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- All dogs shall be shown in a flat buckle or snap collar, plain harness, or properly fitted Martingale (limited slip) collar. No choke collar, prong collars, shock collars, no-pull harnesses, Martingale leads, or head collars are allowed.
- All dogs must be registered with World Cynosport Rally Limited (or previously APDT Rally) or United States Dog Agility Association, Inc. on the day of competition. We regret we cannot accept an entry without a valid WCRL/USDAA registration number. See [www.rallydogs.com](http://www.rallydogs.com) to register online, or complete the “Dog and Junior Handler Registration” form included in this premium list and submit it to the WCRL office as indicated at the bottom of the form.
- Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- The organizing committee may refuse any entry for any reason.
- THERE SHALL BE NO REFUND for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. A dog or handler who suffers an injury and/or illness or bitches that come into season after the closing date may be eligible for a 50% refund of their total entry fee. Written request for refund must be made to the Trial Secretary BEFORE the end of the event, **End Date of Trial**. Please provide documentation from your veterinarian/physician. There will be no refunds if the trial has to be cancelled for any reason.
- Returned checks do not constitute a valid entry. There will be a **\$35.00** service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check where notification is received after event date. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is cancelled without recourse by owner/handler.
- No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike, or any other cause beyond the control of the organizers.
- All competitors through entry at this event grant to World Cynosport Rally Limited, their representatives, agents, and assigns, all rights and permissions to use or appropriate my and the dog’s name, biography, likeness, photograph, voice, performing persona, or other indicia or identity for broadcast, telecast, cablecast, transmission, or distribution in any format or media now known or hereafter to become known and waive any and all rights relative thereto.
- All competitors through entry at this event hereby release WCRL, the hosting club, their representatives, agents, and assigns from any claim or cause of action for invasion of the rights of privacy, right of personality, or any similar right.
- Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes without the express written consent of World Cynosport Rally Limited.
- Dogs must remain under control at all times whether on or off leash while on trial site grounds. Day kenneling only is permitted.
- Please pick up after your dog and yourself.
